3.2. Condition of Green - Rum Jungle Bowls Club

The CEO reported as follows:

The Rum Jungle Bowls Club Green has been deteriorating for the last two years and has reached the stage where the surface cannot be used for play.

The Bowling Green is an iconic feature of Batchelor and requires rehabilitation. Inspection with members of the RJBC Committee (NB Clr. Jones, John Hughes and Lola Stephenson are members), showed that the surface requires total replacement with either new grass or a synthetic surface.

It is recommended that the CEO investigates the costs and benefits of either grass or synthetic resurfacing and reports back to Council in time for the 2010/11 budget deliberations.

3.3. Condition of Batchelor Oval

The CEO reported as follows:

Batchelor oval surface is affected by a large number of protruding tree roots that break the surface of the playing field.

The roots have obviously been an issue for many years.

The protruding roots are a safety hazard for users of the oval and for contractors and staff working and using machinery on the surface.

It is recommended that an arborist's report be obtained seeking recommendations for:

- the safe and economical removal of the tree roots without endangering the trees; and
- measures required to prevent repeat incursions.
